

RULES & REGULATIONS

1. NOMENCLATURE :

The Tournament shall be called the **OINAM IBETON DEVI MEMORIAL MANIPUR UNIVERSITY INTER COLLEGE VOLLEYBALL(M&W) TOURNAMENT, 2024-25.**

2. MANAGEMENT AND CONDUCT :

The tournament shall be managed and conducted by **THAMBAL MARIK COLLEGE, OINAM** through an Organising Committee constituted for the purpose and as per the guidelines of the **AIU & MU Sports Committee.**

3. ENTRIES :

- a. The Entry is open to all the colleges/Institutions affiliated to M.U. Sports Committee.
- b. Only the Entry in the prescribed form and with photographs and relevant documents shall be accepted.
- c. Entry closes on **18-10-2024 at 1.00 pm** & complaints after it shall not be entertained in any case.
- d. Entry Fee for participation in the Tournament is Rs. 3,000/-(separately for Men & Women).

4. VENUE & DATE :

The tournament shall be held at the volleyball ground of **THAMBAL MARIK COLLEGE, OINAM** from **22-10-2024**

5. TEAM COMPOSITION, ELIGIBILITY & DOCUMENTS :

The students participating in the tournament shall fulfil the following **Eligibility Rules of the Association of Indian Universities:**

- a. Only students who are **above 17 years & less than 25 years of age as on 1st July, 2024** can participate.
- b. Not more than 8(eight) years have elapsed since a student passed the examination (e.g. **XII Exam., Hr. Secondary Exam**) qualifying him for first admission to a degree or diploma course of the University, irrespective of any other conditions like change of class/course/faculty, joining class from higher, changing academic to professional courses or vice versa. This includes BPEd, LLB Courses etc.
- c. Only a bonafide, full time student, who is enrolled for a course of the university which is of a minimum duration of one academic year and whose examination is conducted by the university, shall be eligible to participate in the Inter College/University Tournament. This includes B-Voc Courses etc.
- d. Students shall not be full-time employees of Public or Private Sector, as the case may be.
- e. Students passing **XII/Hr/Sr. Sec. Classes from the following Boards/Councils/Commissions** are STRICTLY DEBARRED from participation in any of the Manipur University Inter College Tournaments and consequently to represent Manipur University in the Inter University Sports Tournaments of the Association of Indian Universities due to their **non-recognition by Manipur University :**

1. North East National Board of School Education, Guwahati, Assam.
2. North West Accreditation Commission - North East, Guwahati, Assam.
3. Board of Higher Secondary Education, Delhi
4. Higher Secondary Education Board, Delhi
5. Board of Secondary Hr. Secondary Vocational Education, New Delhi &
6. URDU Education Board, New Delhi.
7. National Institute of Open Schooling, New Delhi

Recognition of other boards may be confirmed from Manipur University

f. The following documents shall be furnished :

Age Proof Certificate (Matriculation Certificate), Certificate for passing 10+ 2 Exam., Certificate for passing the last Exam. of the University and its Marks Sheet, Uni/College Reading Certificate, Latest Identity-Card issued by the Institute, Aadhar Card.

(These documents are compulsory even for AIU Tournaments)

g. Other details : For further details and other rules, AIU Rules shall be applicable.

h. A Team shall consist of a maximum of 12 players

6. MODE OF THE TOURNAMENT :

- The competition shall be played on **KNOCK - OUT** Basis.
- However, if the number of teams is less than 5(five) matches will be played on Round Robin basis
- If the number of teams is 5-6, group league matches shall be played. If there is only 2(two) teams in a group, matches will be played on double leg basis.
- Winner of a group plays against the Runner of the other in the Semi-Finals.

7. TEAM MANAGERS, OFFICIAL MEETING & FIXTURE OF THE TOURNAMENT :

- a. A team shall be led (Managers) by a responsible staff of the Institution/Office.
No student/outsider shall be allowed to lead the team as the manager.
- b. A Meeting along with the Officials/its representatives of the participating institutions shall be held on at at for the smooth and successful conduct of the Tournament.
- c. Fixture of the tournament shall be drawn on the day and time of the Officials' Meeting convened by the Organising Committee.
- d. Fixture shall be drawn as per guidelines given by the MU Sports Committee.

8. RE-SCHEDULING & FIXATION OF MATCHES :

- a. In no case, no request for the postponement/preponement of matches shall be entertained.
- b. However, the organising committee reserves the right to prepone/postpone a match.
 - i) In such a case, 12-24 hours notice is sufficient for the match to be re-fixed.
 - ii) The Organising Committee reserves the right to fix matches even in the morning, if necessary.

9. RULES OF THE GAME :

The Rules of the Game as those currently in force including latest amendment and as adopted by the **State Volleyball Association** shall be applied in the Tournament.

10. ABANDONED MATCHES/WITHDRAWALS/FAILING TO TURN-UP :

- a. If a match has been abandoned as a result of incidents like walk-out by teams, lack of order, spectators invading the field of play etc., the Organising Committee shall decide the course of action to be taken.
- b. If match is **abandoned due to natural conditions like bad weather, heavy rains** or other conditions beyond the control of the Organisers, only that part of the match, which remains to be played, shall be played on the day following the abandoned match.

11. DISCIPLINARY ACTIONS/MEASURES :

- a. All Disciplinary Actions and Disputes arising out of the infringements of the Rules of the Game etc. shall be dealt with Disciplinary Committee of the Tournament.
- b. Other rules adopted by State Volleyball Association shall be followed.

12. PLAYERS DISMISSED FROM THE FIELD OF PLAY/TOURNAMENT :

Players dismissed from the field of play/Tournament by the referee shall be suspended from further play until the case has been decided by the Disciplinary Committee.

13. PROTEST :

- a. Protest, if any, shall be made in writing to the Org. Secy. not later than 1 hour after the close of the match accompanied by a fee of Rs 1,000/- . If the protest is not upheld, the fee of Rs 1,000/- shall be forfeited.
- b. No protest shall be lodged against the field of play and its appurtenances and decisions of the referee on points of facts taken by him on the field of play.
- c. All complaints and any disputes to the qualification/eligibility of the players shall be informed to the concerned referee and Organisers, first verbally before the start of the match and followed by a written protest. However, if the player(s) in question, joins the team at a latter stage of the match, verbal protest may be lodged before the end of the match concerned.
- d. All protests shall indicate proper reasons. *If required, the protesting team shall furnish relevant supporting documents.*
- e. Protests not lodged in the foregoing manner shall not be entertained/investigated.

14. OFFICIATING CHARGES :

Every participating team shall pay to the Organising College an officiating charge of Rs. 500/- (Rupees five hundred) for every match they play as per decision of the MU Sports Committee.
[This is in conformity with AIU Rule A - IX 6(b)-Expenses of Umpires]

15. INTERPRETATION AND RULES NOT PROVIDED FOR :

Matter not provided for in these terms and conditions and any case of discrepancies in the interpretation of the above Rules shall be referred to and decided by the Organising Committee, whose decision shall be final and binding and not subject to appeal.
